ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of this corporation is L.D. HUDSON ENTERPRISES, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually commencing with the filing of these Articles of Incorporation.

address of the principal office for the corporation is Post Office Box 500, Ocoee, Florida 34761.

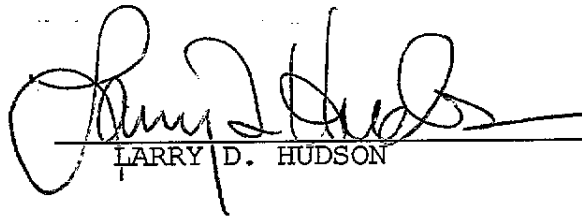

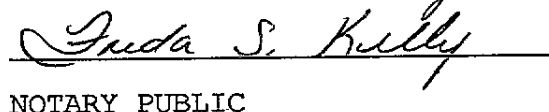
