The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of the corporation shall be: **BRITISH RELIEF, INC.**

DURATION**

The corporation shall exist in perpetuity.

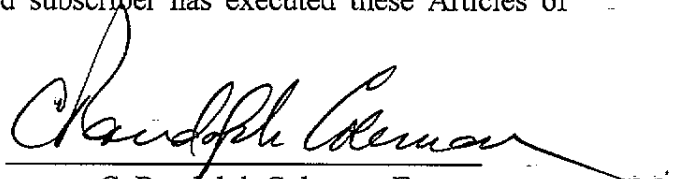

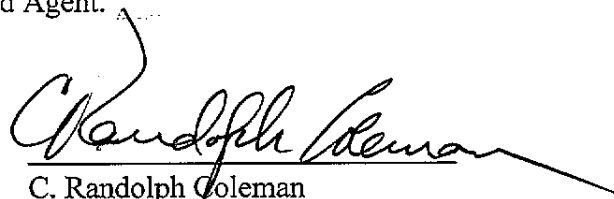
