I would like to reinstate my corporation, (Cartoon Kings, Inc.) EIN #59-3521905. I am enclosing \$600.00 with this letter. I would like to know if you make any exceptions regarding the amount of fees it takes to do this. Due to medical reasons I have been unable to pay my fees in the past 3 years.

When I established this company in 1998 it was with a partner, Jose Gabriel, at 3100 Old Winter Garden Road, Apt. 525, Ocoee, FL 34761. On April 11, 2000 I was hospitalized with a brain hemorrhage, I was in a coma for 2 1/2 days, and in the hospital for a total of 15 days. (The brain hemorrhage was caused by taking over the counter cold medicine.) While I was in the hospital my wife gave the company checkbook to Jose so he could pay himself and our employees. She also informed him of what taxes needed to be paid and who the accountant was so he could take care of everything. Needless to say he did not follow through on anything, so while I was learning how to walk, talk and brush my teeth again, my partner and his wife were destroying the company I worked so hard to build. Two of our employees promptly quit when Jose's wife appointed herself manager or our company.

After leaving the hospital I had to go to therapy for several months to work on regaining my memory, I gradually returned to work a few hours at a time. It has taken me a long time, but I have finally taken care of all of the unpaid taxes and fines that occurred while I was recovering and built my bank account back up after my partner and his wife spent all the money and left me with several overdraft charges and many unpaid bills. Needless to say Jose is no longer my partner.

When we established this company the mailing address was listed under Jose's name - so if any renewal notices were sent regarding the corporation fee - they were not forwarded to me. As a result, I have not paid my corporation fee for several years.
