### ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

### ARTICLE I

# Corporate Name

The name of the corporation is PAULA J. RHOADS, P.A.

### ARTICLE II

# **Address of Corporation**

The address of the principal office of the Corporation, or the mailing address of the Corporation, if the principal office is not yet known, is 201 Airport Road South, Naples, Florida 34104.

### ARTICLE III

# **Duration and Effective Date**

The Corporation shall have perpetual existence, commencing on the date of the execution and acknowledgment of these Articles or upon filing.

### ARTICLE IV

# <u>Purpose</u>

The purpose for which the corporation is organized is to render the practice of law to the public, which shall consist of consulting and rendering legal advice on any cause or matter whatsoever, including laws, statutes, rules, regulations, contracts, legal principles and other documents or relationships having legal effect; drafting documents and opinions for the purpose of
