- 4) That the Corporation understands that the name of the Corporation is available for immediate use by any other Corporation.

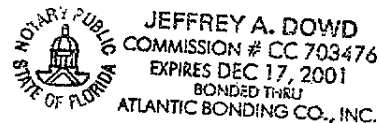

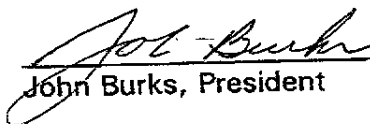
