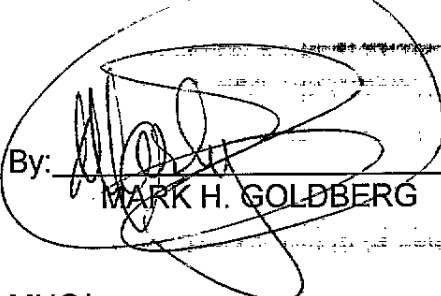

**ARTICLES OF AMENDMENT
SUPER SKATES X, INC.**

Pursuant to §607.1006 Florida Statutes, the Articles of Incorporation of the above-named Corporation are amended as follows:

1. Article I. of the Articles of Incorporation shall be amended to read as follows:

ARTICLE I. NAME

The name of the corporation shall be:

SUPER KIDS IV, INC.

The address of the principal office of this corporation shall be 1378 S.W. 160TH Avenue, Sunrise, FL 33326, and the mailing address of the corporation shall be the same.

2. The foregoing amendment was adopted on July 28, 1999 by the affirmative vote of the Shareholders of a majority of the shares entitled to vote on the amendment, in accordance with Florida Statutes Section 607.1006(1)(f).
