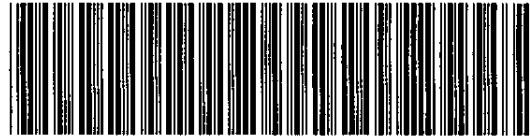

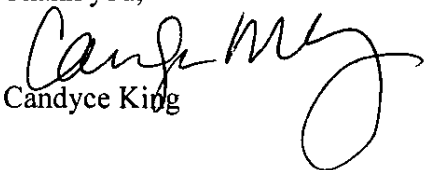

FIRST: Article 1 is amended to change the name of the corporation from King Dolaghan, P.A. to Candyce M. King, P.A.

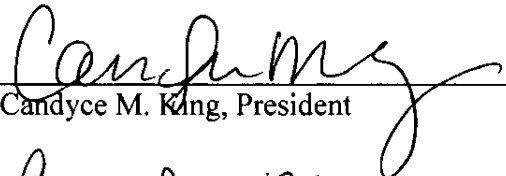
SECOND: T. Eileen Dolaghan is removed as Vice President and Secretary. Candyce M. King is appointed Vice President and Secretary.

THIRD: Candyce M. King currently holds 100% of the outstanding shares of the corporation.

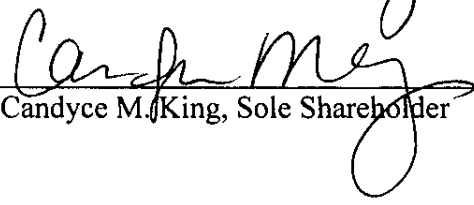
