
RE: 2001 Uniform Business Report, Document # P98000058534, Waiver Request

To whom it may concern:

Along with this letter, please find my completed 2001 UBR and filing fee of \$150.00 per instructed, by Kristen in Internet Access, Division of Corporations. As I explained in my email to Kristen, when I went to see if there was any Telcom mail this past week, I found the 2001, Uniform Business Report that stated that my original report had not yet been filed. I was completely taken by surprise and realized only then, that I had never received the first notice. When I talked to the person behind the counter about the original notice, she suggested that *if* it was sent out by the state, the possibility existed that it was put in the wrong box. She pointed out that on my form, where it should have read *Suite*, the state had made a typo and put *Suiste*. She said that if the same error was made on the 1st form, the mail sorter may have mistakenly, distributed the form to someone that had a name similar to *Suiste*. I understand, that remembering the various filings and associated fees are ultimately my responsibility, regardless, of whether the original error was due to the state or the mail center. However, since business has been basically nil this year, I do not deal with my "corporation" on a day-to-day basis. The 1st notice would have *definitely* served as my reminder to file the 2001 UBR. I am therefore asking you to please, grant this request for a waiver of the \$400.00 late fee, since an error, possibly on the part of the state, prevented me from receiving and filing my form, prior to the May 1st deadline.
