The undersigned incorporators, each of whom is licensed or otherwise legally authorized to practice the profession of attorneys at law in the State of Florida, associate themselves with the Florida Professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act and adopt the following articles of incorporation for the corporation:

ARTICLE I

NAME

The name of the corporation is THE LAW PRACTICE, P.A.

ARTICLE II

PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The address of the corporation principal office is 1250 SW 27th Avenue #306, 33135 City of Miami, County of Miami-Dade, State of Florida,

The name of the initial registered agent of the corporation, located at that office, is Maria S. Estevez.

ARTICLE III

DURATION

The period of the corporation duration shall be perpetual, until dissolved on a vote of the shareholders as provided in these articles.

ARTICLE IV

PURPOSE

The purpose of the corporation is to practice the profession of Law. The sole and exclusive professional service to be rendered by the corporation is Legal Services.

This corporation is organized for the following purposes:

a. To engage in the practice of law as a professional law corporation and to carry on services incident to the practice of law. The practice of law is the sole and exclusive professional service to be rendered by this corporation.

b. To own property, enter into contracts, and to carry on any business necessary or objects of this corporation..

The professional services of this corporation shall be carried out only through the attorneys, each of whom has been admitted to the bar , and is duly authorized to practice law in the State of Florida, its officers, employees, and agents.

ARTICLE V

CAPITAL STOCK

The total number of shares of stock which the corporation shall be authorized to issued or have outstanding at any one time is 100 shares. These shares shall be of a single class of common stock, and shall have a value of \$ 1.00 per share.

ARTICLE VI
CAPITALIZATION

The amount of capital with which the corporation will begin to practice the profession of Attorneys at Law is not less than ONE HUNDRED (\$100.00) DOLLARS.

ARTICLE VII
CORPORATE POWERS

The corporation shall have all the rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida, including, but not limited to, the following: to provide legal services to the public.

DIRECTORS

The corporation is to be managed by a board of director(s). The number of director(s) constituting the initial board of director(s) is one (1) and the name(s) and address(es)

The initial director(s) shall hold office until their successors are elected and qualified as provided in the bylaws. Then the term of office of each director shall be two (2) and until the election and qualification of a successor. The number of director(s) set forth in these articles if incorporation and constituting the initial board of director(s) shall be the authorized number of director(s) until that number is changed by a bylaw duly adopted by the shareholder(s).

ARTICLE X

BYLAWS

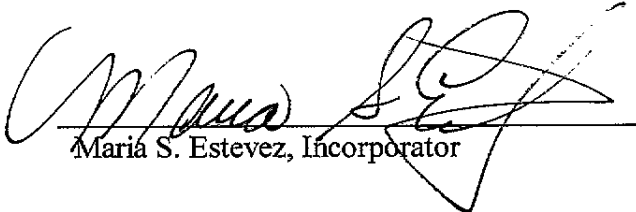
The initial director(s) shall submit the purposed bylaws to the shareholders at a meeting to be held for that purpose not more than 15 days following the issuance of the Certificate of Incorporation. Following the adoption of bylaws by affirmative vote of the majority of the stockholders, the internal affairs of the corporation are to be regulated and managed in accordance with the bylaws.

ARTICLE XI

DISSOLUTION

The corporation may be dissolved at any time by a unanimous written consent of the shareholders; of the outstanding shares of the corporation entitled to vote. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by the shareholder.
