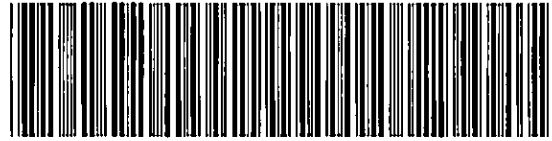

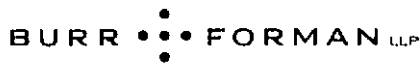

Adirondack Air, Inc. (Florida document number P98000058553) (the "Corporation") was administratively dissolved on October 4, 2002. The Corporation desires to file a reinstatement application and to pay the applicable fees and penalties associated therewith.

The Corporation cannot, however, file the reinstatement application because the name "Adirondack Air" is no longer available due to a limited liability company named Adirondack Air LLC, which has also been administratively dissolved.

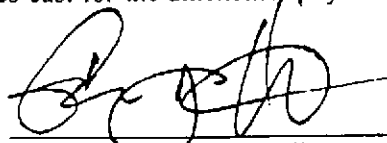
The Articles of Incorporation (the "Articles") for Adirondack Air, Inc. (the "Corporation") were filed on June 29, 1998 and assigned Florida document number P98000058553.

The Articles are hereby amended as follows:

1. Article I of the Articles is hereby deleted in its entirety and replaced with the following:

The name of the Corporation is Adirondack Air of Florida, Inc.

The above amendment was adopted by the board of directors and all of the shareholders of the Corporation on February 27, 2021. The number of votes cast for the amendment by the shareholders was sufficient for approval.
