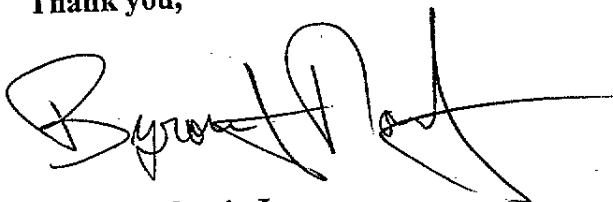

**ARTICLES OF INCORPORATION**  
**OF**

**ARTICLE ONE**

The name of the corporation is:

The period of duration is perpetual.

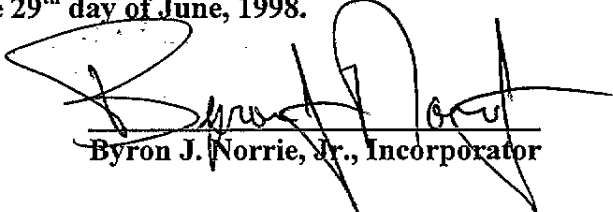
