**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME**

The name of this corporation is MAIDA-BENSON ENTERPRISES, INC.

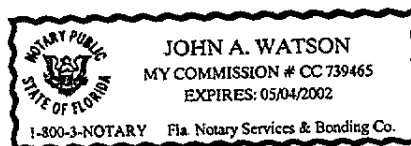
