In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I
NAME**

The name of the corporation ("Corporation") is **TECHNICAL CONTAINER CORP.**

**ARTICLE II
CORPORATE PURPOSE**

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE III
EFFECTIVE DATE**

The existence of the corporation shall begin on filing with the Secretary of State

**ARTICLE IV
ADDRESS**

The street address of the principal office of the Corporation is :

That said corporation shall have the right and authority to do business at such other place or places within or without the State of Florida as the corporation may, by resolution, designate.

ARTICLE V
CAPITAL STOCK

The maximum number of shares this Corporation is authorized to issue is **TEN THOUSAND(10,000)** shares of \$1.00 par value common stock, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.



INDEMNIFICATION


