ARTICLES OF INCORPORATION OF

98 JUL - I AMII: 25 SECRETARY OF STATE TALLAHASSEE FLORIDA

The undersigned subscribers to the Articles of Incorporation, who are natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I. NAMES

The name of the corporation shall be:

WORLD COMMODITIES CORPORATION

The address of the principal office of this corporation shall be 1426 South Warren Avenue, Lakeland, Florida, 33803, and the mailing address of the corporation shall be the same.

ARTICLE II. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock.

ARTICLE III. ADDRESS
