## ARTICLES OF AMENDMENT OF EASYFAST CORPORATION

SORTH OF THE STATE OF THE STATE

THE UNDERSIGNED, WILLIAM K. LOVELACE, being the Vice President and Assistant Secretary, of EASYFAST CORPORATION, does hereby certify that the following Amendment to the Articles of Incorporation of EASYFAST CORPORATION was approved by the Stockholders of said Corporation on the 16th day of February, 1999, at a duly called meeting of the Stockholders and Directors of the Corporation.

The Articles of Incorporation of EASYFAST CORPORATION are hereby amended as follows:

1. Article I is hereby deleted and the following is inserted in lieu thereof:

## ARTICLE I

- 1. The name of the Corporation shall be SAND KEY COMPUTERS, INC.
- 2. All amendments included herein were adopted pursuant to Section 607.1006, F.S., and there is no discrepancy between the Corporation's Articles of Incorporation as theretofore amended other than the inclusion of these amendments and the omission of matters of historical interest.
- 3. This Amendment has been approved by unanimous consent of all of the Shareholders of the Corporation who are entitled to vote.
- 4. This Amendment shall be effective upon its filing with the Secretary of State, State of Florida.
