#### ARTICLES OF INCORPORATION

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

#### ARTICLE I

# NAME AND PRINCIPAL ADDRESS OF CORPORATION

The name of this corporation shall be SIMPLY ELEGANT SALONS, INC. and the principal address of the corporation is 6802 West Hillsborough Avenue, Unit 11, Tampa, Florida 33634.

#### ARTICLE II

## COMMENCEMENT AND DURATION

The Corporation shall commence to exist as of the date of the filing of these Articles of Incorporation with the Secretary of State's Office, and shall exist perpetually thereafter until dissolved.

#### ARTICLE III

#### PURPOSE

The corporation is organized for the purpose of a full-service specialty beauty salon transacting any and all lawful business.

#### ARTICLE IV

#### STATED CAPITAL

The corporation is authorized to issue 1,000 shares of common stock having no par value per share.
