**ARTICLES OF INCORPORATION
OF

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under laws of the State of Florida.

ARTICLE I – NAME

ARTICLE II – COMMENCEMENT AND DURATION

The corporation is to commence its corporate existence on the date of subscription and acknowledgment of these article of incorporation and shall exist perpetually thereafter until dissolved according to law.


