ARTICLES OF INCORPORATION

OF

SEA SHORE SEAFOOD ENTERPRISES, INC

WE, the undersigned, hereby associate together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provision of the laws of said state, providing for the information, liabilities, rights, privileges and immunities of a corporation for profit.
