The undersigned subscriber hereby files these Articles of Incorporation with the Secretary of State of the State of Florida, for the purpose of forming a corporation for profit in accordance with Chapter 607, Florida Statutes (the "Florida Business Corporation Act") and Chapter 621, Florida Statutes (the "Professional Service Corporation and Limited Company Act"), collectively, the "Act".

ARTICLE ONE

NAME AND MAILING ADDRESS OF CORPORATION

The name of this corporation is **ALLERGY & ASTHMA CENTRE, P.A.** (the "Corporation"). The mailing address of the Corporation is 5405 Park Street, North, St. Petersburg, Florida 33709.

ARTICLE TWO

CORPORATE PURPOSE/OWNERSHIP LIMITATION

The Corporation is being formed to provide medical services and to engage in any other activities permitted by the Act. If any member, officer, shareholder, agent, or employee of the Corporation, who has been rendering professional services to the public becomes legally disqualified to render such professional services within this State or accepts employment that, pursuant to existing law, places restrictions or limitations upon that person's continued rendering of such professional services, that person shall sever all employment with, and financial interests in the corporation.

ARTICLE THREE

CAPITAL STOCK

The Corporation is authorized to issue 10,000 shares of \$1.00 par value common stock.

ARTICLE FOUR

CORPORATE EXISTENCE AND DURATION

The period of duration of the Corporation shall be perpetual commencing on the date of execution and acknowledgement of these Articles.

ARTICLE FIVE

INITIAL REGISTERED OFFICE AND REGISTERED AGENT

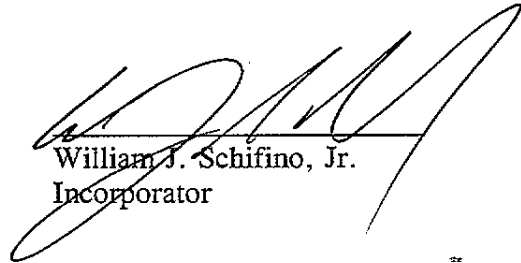
The street address of the initial registered office of the Corporation is 201 N. Franklin Street, Suite 2600, Tampa, Florida 33602, and the initial registered agent is

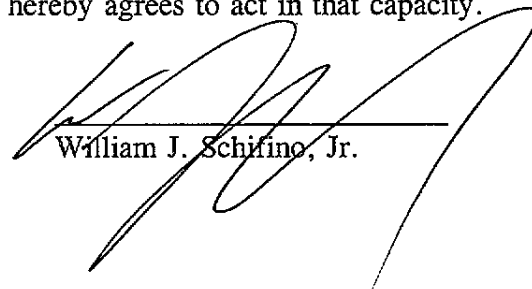
