ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I. NAME.

The name of the corporation shall be WEST COAST MEDICAL CRYSTAL RIVER, P.A.

ARTICLE II. PRINCIPAL OFFICE & MAILING ADDRESS.


