

ARTICLE I - CORPORATE NAME

The name of this corporation is VINYL SOLUTIONS BY JASON INC., whose principal office and mailing address is 4325 Carlysle Avenue, Titusville, Florida 32780.

ARTICLE II - NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK



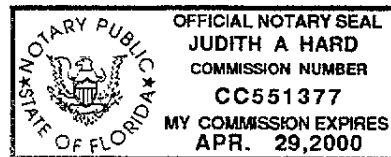
