ARTICLE I

The name of the corporation is PUMA INVESTMENTS, INC.

ARTICLE II

This corporation shall be perpetual commencing with the filing of these Articles.

ARTICLE III

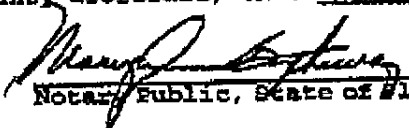
