Dear Sir or Madam:

On Friday, July 7, 2001, we received the 2001 Uniform Business Report packages for Moody & Shea, P.A. and for Dispute Resolution & Management, Inc. which indicated that our annual reports had not been filed prior to the deadline of May 1, 2001. As we have always attended to the filing of these annual reports in a timely manner, we were very surprised to receive these notices. Please find enclosed the completed annual reports for both businesses.

In our review of matters concerning why these reports had not been timely filed we found the prior 2001 Uniform Business Report packages for both businesses unopened in an unmarked folder in the desk of our former legal secretary/office manager, our only full-time employee, who left our employ in March, 2001, and has not, as of yet, been replaced. These forms had never been brought to our attention (nor had the envelopes ever even been opened by the legal secretary/office manager) and we had believed that the annual reports had already been timely filed as they had been in prior years by the legal secretary/office manager.

Moody & Shea, P.A. is a two (2) attorney law firm and Dispute Resolution & Management, Inc. is the corporate entity created for the one (1) attorney who is a certified mediator for conduct of his mediation. Since March of 2001, we have continued to not only operate our businesses, but also struggled to perform all administrative and financial operations previously performed by the legal secretary/office manager ourselves as we have thus far been unable to find a qualified replacement to take over these duties.

As Dan Moody is a single parent of two (2) young sons and Susanna Shea, his sister

and law partner, who lives in the home and provides back-up child care and household support, were also in the process of moving their residence during this time, both of us have been extremely busy. The matter of not having signed the annual reports for the two (2) business entities did not occur to either of us during this time.

As both business entities are small business operations with limited revenues and productivity has been substantially reduced due to the loss of the support staff employee referenced above; the demands and responsibilities associated with the business, family, and household relocation; as well as a general reduction in client demand for services, payment of a penalty for late filing of the annual report for the businesses constitutes an extreme financial hardship. As no mediation activity has been performed and, thus, no income received from mediation, Dispute Resolution & Management, Inc. has not even been able to afford to open a bank account to date.

Due to the financial hardship to the small business operations and the fact that the original annual report notices were never delivered to the two (2) individuals who own, operate, and manage the businesses, we respectfully request that the penalties, totaling \$800.00, for late filing of the annual reports be waived in this case.
