ARTICLE VIII. SPECIAL PROVISIONS

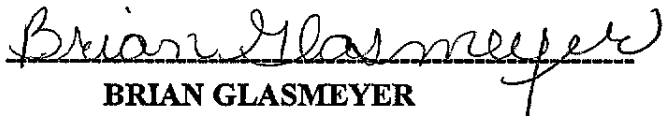

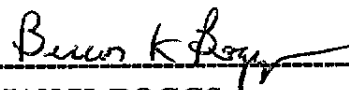
