I can not find any record of my 150.00 filling fee payment nor any record of the application to fill out. As we previously discussed the fact that the company mailing address (687 Alderman Rd. Suite 137, Palm Harbor, FL 34683) is one in a bank of many 4 inch by 4 inch mail slots with open backs similar to any Mailboxes Etc. type of business for example, I originally thought that it may have gotten misplaced or inadvertently pushed out of the back of the slot, and since anything larger than most letters will not fit and requires a separate pick-up on my part (a note is left to tell me a that I have something that won't fit in the slot and to go to the front counter and get it separately) although if the original form is the same size as the reinstatement form I just received that is not as likely to have occurred but may have. That is one reason I requested that all correspondence from your office be mailed to my home address, (1190 Bee Pond Rd.) instead of the Postal Center, it is probably better. Although I am fairly new at this, July of 1998, I have been diligently trying to run a successful business which includes all of the work, paperwork, travel, etc. alone and the last thing I want or can afford to have is something simple such as the lack of a form to complicate things and make it harder yet to succeed. As far as other fillings go my quarterly State Sales and Use Tax forms are always on time including the appropriate funds as well as everything else that I know of involving the business is concerned. I honestly can't say why that form was not received/mailed out with the research I have conducted (I have record of my 1999 150.00 fee payment) my feeling is that if I received the form it was filled out and mailed. Again I am not blaming anyone, and it wouldn't be truthful to say that I know everything about every paper and every other aspect of this business including all of important forms that I am responsible for, but I just can not find an answer no matter how far back or how thoroughly I check, I can say that my other forms have been on time and would greatly appreciate the opportunity to make things right with this particular one. Please accept my filling fee as payment due and my apology for the extra work and many phone calls that were responded to on your part concerning this matter.
