The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I - NAME OF CORPORATION**

The name of the corporation shall be **Automated Commercial Fueling of Tampa Bay, Inc.**

**ARTICLE II - PRINCIPAL OFFICE**

The initial principal office and mailing address for the corporation is at 135 West Central Blvd., Suite 1100, Orlando, Florida 32801.

**ARTICLE III - TERM OF EXISTENCE**

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.

**ARTICLE IV - PURPOSES**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE V - CAPITAL STOCK**
