Articles of Incorporation

The undersigned desiring to form a corporation for the purposes hereinafter stated under and pursuant to the laws of the State of Florida, does hereby declare as follows:

<u>ARTICLE I.</u>

<u>NAME</u>

The name of the corporation shall be SMART REAL ESTATE DECISIONS, INC.

ARTICLE II.

BUSINESS AND PURPOSE

The nature of the business which may be transacted by the corporation is as follows: The publication of and marketing of real estate educational manuscripts and to perform various other related and unrelated real estate functions. This corporation may also engage in any activity or business permitted under the laws of the State of Florida, and shall enjoy all the rights and privileges of a corporation afforded by the laws of the State of Florida.

ARTICLE III.

RIGHT TO PURCHASE OWN SHARES

The corporation shall have the right to acquire its own shares from time to time, upon such terms and conditions as the Board of Directors shall fix.

ARTICLE IV.

STOCK

The maximum number of shares of stock which this corporation is authorized to have outstanding at any time shall be five thousand (5000) shares of common stock having a par value of one dollar (\$1.00) per share.
