We, **THE UNDERSIGNED**, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the state of Florida providing for the formation, liability, rights, privileges and immunities of corporations for profit.

This Corporation may be a Sub-Chapter (S) Corporation as defined by the Internal Revenue Code.

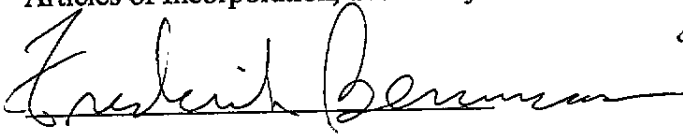

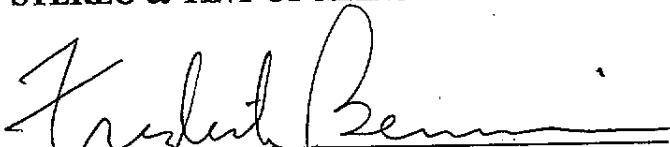
