ARTICLE 1. CORPORATE NAME

*The name of this corporation shall be MEDICAL JOBS RECRUITERS, Inc.*

ARTICLE 2. NATURE OF BUSINESS AND POWERS

*The general nature of the business to be transacted by this Corporation is to engage in any and all businesses permitted under the law of the State of Florida*

ARTICLE 3. CAPITAL STOCK.

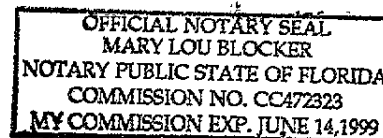
