ARTICLE IV - INITIAL REGISTERED AGENT

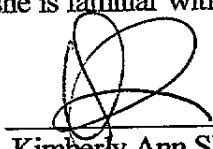

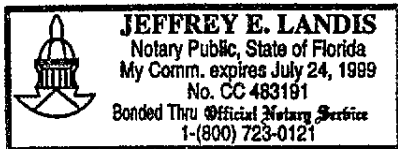
