## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF MARKETPLACE DENTAL OKEECHOBEE,

Pursuant to the provisions of Section 607.1006 Florida Statutes, this Florida professional corporation hereby adopts the following articles of amendment to its articles of incorporation:

**FIRST:** The following amendments are hereby adopted:

Article I. Name. The name of this Florida professional corporation is: Gentle Dental Group of West Palm Beach Okeechobee, P.A.

Article II. Address. The mailing address of the Corporation is: 17968 Fieldbrook Circle, Boca Raton, FL 33496.

Article III. Registered Agent. The name and address of the registered agent of the Corporation is: Jared W. Woolf, D.D.S., 17968 Fieldbrook Circle, Boca Raton, FL 33496.

Article IV. Board of Directors. The name of each member of the Corporation's Board of Directors is: Jared W. Woolf, D.D.S. The corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time pursuant to the bylaws adopted by the board of directors, but any amendment to the bylaws which either increases or decreases the number of directors shall be ratified by a majority of the shareholders, provided that the corporation shall always have at least one director. To the fullest extent permitted by applicable law as the same exists or may hereafter be amended, a director or officer or former director or officer of this Corporation shall not be liable to the corporation or its stockholders for monetary damages for a breach of fiduciary duty as a director or officer. The Corporation shall fully indemnify every current and former director and officer of the Corporation from personal liability to the fullest extent permitted by applicable law. Any repeal or modification of this ARTICLE IV shall not adversely affect any right or protection of an officer or director of the corporation existing at the time of such repeal or modification.

**SECOND**: The date of each amendment's adoption is: March 4, 1999.

**THIRD**: This amendment was approved by the shareholders of the Corporation. All of the issued and outstanding shares were cast in favor of approving this amendment.
