I recently received my 2nd notice of the 1999 Profit Corporation Annual Report, with a filing fee of \$550.00. I did not receive the first notice which I understand was mailed in January, or I certainly would have filed by June 11 with the filing fee of \$150.00.

I suspect that I did not receive the first filing notice because when I originally incorporated to do business as "Blimpie Subs & Salads", some of my mail was coming to my business address at 1921 N. Belcher Road, Clearwater, FL 33763 (Example "A") and some was coming to my home address at 16720 Longleat Drive, Lutz, FL 33549. In an effort to be consistent, I had waited until January 1999 to forward all of my business mail to my business address in Clearwater. Herein lies the problem. My "Blimpie Subs" business is located inside of an Albertson's grocery store and we share the same street address. The U.S. Postal Service delivers all of the mail to Albertson's, and I must wait for an Albertson's employee to sort and deliver my mail to me. These employees recognize my business as "BLIMPIE'S", and not my corporate name of "Orio's Doublestuff Enterprises" so needless to say, there has been much confusion with my mail. I have since rectified the situation, and sincerely apologize for any inconvenience.
