

OF

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is TRESSEL BOOKKEEPING AND SECRETARIAL SERVICES, INC. The principal place of business is 1505 S.E. 40th Street, Suite C, Cape Coral FL 33904. The mailing address of the corporation is 1505 S.E. 40th Street, Suite C, Cape Coral, Florida, 33904.

ARTICLE II - Commencement and Duration

The corporation is to commence its existence on the date of filing, and shall have perpetual existence thereafter until dissolved by law.


