ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
ROMANTIC ENCOUNTERS, INC.

Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of ROMANTIC ENCOUNTERS, INC. (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is ROMANTIC ENCOUNTERS, INC.

SECOND: Article I of the Articles of Incorporation is hereby deleted in its entirety and the following inserted in lieu thereof:

"The name of the Corporation is PARCOM, INC."

THIRD: The foregoing amendment was adopted on July 21, 1998 by written consent of the shareholders and directors of the Corporation, constituting a sufficient number of votes for the amendment to be approved in accordance with Florida Statutes.
