
BOARD OF DIRECTORS:

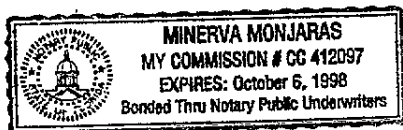

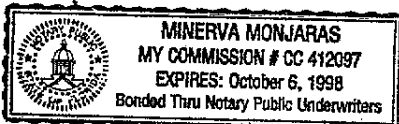
