

#### ARTICLES OF INCORPORATION

OF

# CRYSTAL SERVICES, INC.



The undersigned subscriber to these Articles of Incorporation, a nature person complement to contract, hereby forms Corporation under the Laws of the State of Florida.

# ARTICLE L NAME

The name of the Corporation shall be: Crystal Services, Inc.

# ARTICLE II. NATURE OF BUSINESS

The general nature of the business of businesses of the Corporation and the objects and purposes proposed to be transacted, promoted or carried on by it, are as follows:

- a. To clean and sanitize residentail and commercial property.
- b. To manufacture, purchase or otherwise acquire, and to own and mortgage, pledge, sell assign and transfer or otherwise dispose of, and to invent, trade, deal in and deal with goods wares, merchandise and other personal property of every class and description whatsoever.
- c. To buy, sell, manufacture, repair, alert and exchange, let or hire, export and deal in articles and things which may be required for the purpose of any business or commonly supplied or dealt in by persons engaged in such business, or which may seem capable of being profitably dealt with in connection with any of the said business.
- d. To guarantee, or to acquire by purchase, subscription or otherwise, hold for investment or otherwise, sell, assign, or transfer, mortgage, pledge or otherwise dispose of the shares of the capital stock of, or any bonds, securities or evidence of indebtedness created by an other corporation or corporations of the State of Florida or any other state or government, domestic or foreign; and while the owner of any such stocks, bonds, securities or evidences of indebtedness, to exercise all rights, powers and privileges of ownership, including the right to vote thereon for any and all purposes; to aid by loan, subsidy, guaranty, or in any other manner whatsoever so far as the same may be permitted in the case of the corporation organized under the General Corporation Laws of the State of Florida, any corporation whose stocks, bonds, securities or other obligations are or may be in any manner and at time owned, held or guaranteed, and to do any and all other acts or things for the preservation, protection, improvement or enhancement in value of any such stocks, bonds, securities or other obligations; and to so all and any such acts of things designed to accomplish any such purpose.
- e. To acquire, hold, own, dispose of, and generally deal in grants, concessions, franchises and contracts of every kind; to cause to be formed, to promote and aid in any way in the formation of any corporation, domestic of foreign.
- f. To acts financial, business and purchasing agent for domestic and foreign corporation, individuals, partnerships, associations, state government or other bodies.

- g. To acquire in any manner, enjoy, utilize, hold, sell, assign, lease, mortgage or otherwise dispose of, letter patent of the United State or of any foreign country, patents, patent, right, licenses and privileges, inventions, improvements and processes, copyrights, trademarks, and trade names or pending application therefore, relating to useful in connection with any business of the Corporation or any other corporation in which the Corporation may have any interest as a stockholder or otherwise.
- h. To borrow money and contract debts when necessary for the transaction of its business or for the exercise of its corporation rights, privileges or franchise or for any other lawful purpose of its incorporation; to issue bonds promissory notes, bills or exchange, debentures and other obligations and evidence of indebtedness payable at a specified time or times, or payable upon the happening of a specified event or events, secured or unsecured, from time to time, for moneys borrowed, or in payment for the property acquire, or for any other objects or purposes of the corporation or for any of the objects of its business; to secure the same by mortgage or mortgages, or deeds or deeds of trust, or pledge or other lien upon any of all of the property, rights privileges or franchises of the Corporation, whereinsoever situated, acquired or to be acquired and to confer upon the holders of any debentures, bonds or other evidences of indebtedness of the Corporation secured or unsecured, the right to convert the principle thereof into any preferred common stock of he Corporation, now or hereafter authorized, upon such terms and conditions as shall be fixed by the Board of Directors; to sell, pledge or otherwise dispose of any or all debentures or other bonds, notes, and other obligations in such manner and upon such terms as the Board of Directors may deem judicious, subject, however to the provisions of Article III hereof.
- i. To acquire by purchase, subscription or otherwise, and to hold for investment, and to hold for investment, and to own, hold, sell, vote and handles shares in other corporations.
- j. To have one more offices; conduct its business and promote its object within and without the State of Florida, in other states, the District of Columbia, the territories possessions and decencies of the United States, and in foreign countries, without restriction as place or amount.
- k. To do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the purposes or the attaining of any of the objects or the furtherance of any of the power enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the Corporation, as principal, agent, director, trustee or otherwise, and in general, either alone or in association with other corporations, firms or individuals, to carry on any or in association with other corporations, firms or individuals, to carry on any lawful business necessary or incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes and objects forth in these Articles of Incorporation of any amendment thereof.
- l. In addition to the foregoing, the Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The forgoing paragraphs shall be constructed as enumerating both objects and power of the Corporation; and it is hereby expressly provided that the forgoing enumeration of specific powers shall not be held to limit or restrict in any manner the power of this Corporation.

# ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding as any one time is 1000 shares of common stock having a par value of \$1.00 per share.

# ARTICLE IV. TERM OF EXISTENCE

The corporation is to exist perpetually.

# ARTICLE IX. REGULATION OF BUSINESS AFFAIRS

The following additional provisions for the regulation of the business and for the conduct of the affairs of the Corporation, its stockholders and directors are hereby adopted as a part of these Articles of Incorporation.

- a. The Board of Directors from time to time shall determine whether and to what extent, and at which time and places, under what conditions and regulations, the accounts and books of the Corporation or any of them shall be open to inspections of the stockholders, and no stockholder shall have any right to inspect any account or document of the Corporation, except as conferred by statute or authorized by the Board of Directors, or by resolution of the stockholders.
- b. No person shall be required to own, hold or control stock in the Corporation as a condition precedent to holding an office in this Corporation.
- c. The Directors may be prescribe a method or methods for replacement of lost certificates, and prescribe reasonable conditions by way of security upon the issue of new certificates therefore.
- d. The original incorporators of the Corporation shall have the right upon its organization, to assign and deliver their subscriptions of the stock as set forth in Article X hereof to any other person, or to the firms or corporations who may hereafter become subscribers to the capital stock of the Corporation, who, upon acceptance of such assignment, become subscriber to the capital stock of the incorporators, and assume and carry out all of the rights, liability and duties entailed by said subscription, subject to the laws of the State of Florida, and the execution of the necessary instruments of assignment.
- e. No contract or other transaction between the Corporation and any other corporation in the absence of fraud, shall be affected or invalidated by the fact that any one or more of the Directors of the Corporation is or are interested in, or is a Director or officer or a Directors or officers of such other corporation, and any Director or Directors, individually or jointly, may be party or parties to, or may be interested, and each and every person who may become a Director of the Corporation may vote upon any contract or other transaction between the Corporation and any subsidiary or controlled company.
- f. Unless otherwise determined by the Board of Directors, any holder of stock of the Corporation shall be entitled as a matter of right, to purchase or subscribe for any stock of any class which the Corporation may issue or sell whether or not exchangeable for any stock of the Articles of incorporation of the Corporation as originally filed or by any amendment thereof or out of shares of stock of the Corporation acquired by any amendment thereof or out of shares of stock of the Corporation acquired by it after the issue thereof and whether issued for cash, labor done, personal property, or leases thereof.

# ARTICLE X. RESTRICTION ON TRANSFER OF SHARES

Any shareholder desiring to transfer any stock shall do so only in accordance with the terms set forth in the by-laws or by separate agreement of the stockholders, which agreement, if any, shall be noted on the face of each certificate of stock issued by the corporation.
