

ARTICLES OF INCORPORATION

OF

PETERSEN GROUP INVESTMENTS, INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE: NAME

The name of the Corporation is PETERSEN GROUP INVESTMENTS, INC. The principal address is 10401 Piper Drive, New Port Richey, FL 34654.

ARTICLE TWO: TERM OF EXISTENCE


