## ARTICLES OF INCORPORATION OF LITTLE FACES, INC.

We, the undersigned subscriber to these Articles of Incorporation, natural personation competent to contract, hereby form a corporation under the Laws of the State of Florida.

Article I- Name

The name of the corporation shall be LITTLE FACES, INC.

Article II- Nature of Business

The general nature of the business to be transacted by the Corporation and its objects and powers shall be to engage in any activity or business permitted under the laws of the United States and of the State of Florida.
