The undersigned incorporator hereby forms a professional service corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of the corporation is *Scott D. LaRue, P.A.*

ARTICLE II ADDRESS

ARTICLE III COMMENCEMENT OF CORPORATE EXISTENCE

The corporation's existence will commence *July 1, 1998*; provided however, that such date is within five business days prior to the date these Articles of Incorporation are filed by the Department of State of the State of Florida. 
