

ARTICLE I.  
CORPORATE NAME AND ADDRESS

The name of this Corporation shall be:

**TOTAL VISION CARE, P.A.**

and its principal place of business shall be 18610 N.W. 67th Avenue, Miami, Florida 33015.

ARTICLE II.

NATURE OF CORPORATE BUSINESS

This Corporation, through its Officers and Employees shall be authorized to engage in every aspect and phase of the practice of optometry within the State of Florida; to engage in any activities which will facilitate and promote the practice of optometry through its Officers and Employees; and to invest and reinvest its funds in real estate, mortgages, stocks, bonds and any other type of investments within the meaning of Section 621.08 of the Professional Service Corporation Act; and to purchase and own real and personal property necessary for the rendering of professional services within the practice of optometry. This Corporation shall not be authorized to engage in any business other than the practice of optometry.

ARTICLE III.

CAPITAL STOCK

This Corporation is authorized to issue a maximum of One Thousand (1,000) shares of stock. The shares of stock authorized shall be common stock having a par value of One Dollar (\$1.00) per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors.

PROFESSIONAL SERVICE CORPORATION ACT



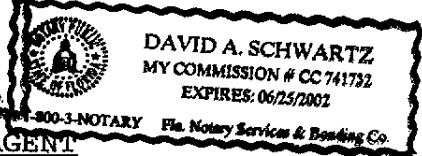
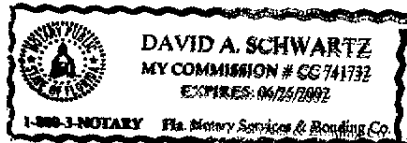
