Articles of Incorporation

ARTICLE I

<u>NAME</u>

The name of the Corporation is **B. J. Patterson Services, Inc.** The principal office address and the mailing address of said Corporation is 5220 Timuquana Road Jacksonville, Florida 32210.

ARTICLE II

DURATION


