ARTICLE VI - INCORPORATOR



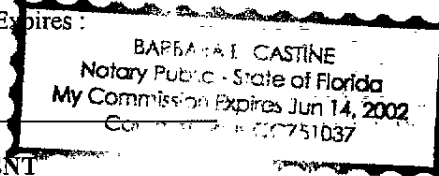
