The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is Stokes & Bush Properties Company, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged.

ARTICLE III - PURPOSES
