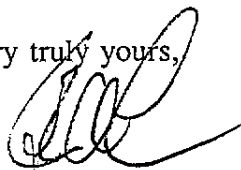

ARTICLE I. Name: The name of this corporation shall be RAN-BOB, INC.

ARTICLE II. Principal Office and Mailing Address: The principal office and mailing address of this corporation shall be: *6175 Sand Pines Estates Boulevard, Orlando, Florida 32829.*

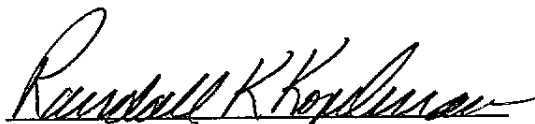

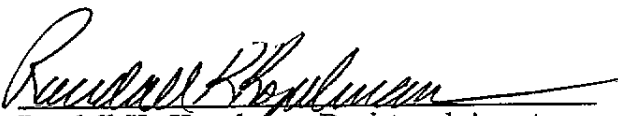
