The undersigned, acting as incorporator of a corporation under the Florida General Corporation

Act, adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I

The name of the corporation is LifeGuide, Inc., whose principal place of business is 2420 S.E. 17th Street, apartment 305, Ft. Lauderdale, Florida 33316.

### ARTICLE II

The period of duration of the corporation is perpetual.

### ARTICLE III
