## **ARTICLE I. NAME**

The name of the corporation shall be

## **ARTICLE II. NATURE OF BUSINESS**

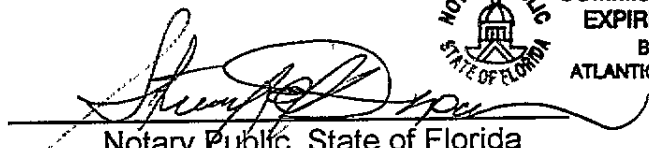
