

## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF TWENTY FIRST CENTURY RECYCLING, INCSECRETARY OF STATE

FILED 01 MAR 30 PM 3: 15

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act (the "Act"), the Articles of Incorporation of Twenty First Century Recycling, Inc. (the "Corporation") are hereby amended according to these Articles of Amendment:

The name of the Corporation is Twenty First Century Recycling, Inc. FIRST:

SECOND: The First Article of the Articles of Incorporation is amended in its entirety to read as follows:

> FIRST: The name of the Corporation is FWRP Corporation (the "Corporation").

The foregoing amendment was adopted by Written Consent of the THIRD: Shareholders, dated as of March 22, 2001, pursuant to the provisions of Section 5 607.1003(6) and 607.0704 of the Act.
