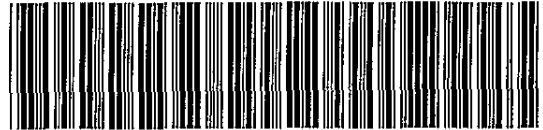

The purpose of the amendment is to effect a name change from International Hair and Beauty Systems, Inc. to Dare To Be Different, Inc.

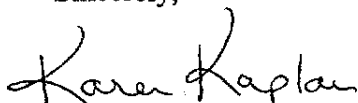
