ARTICLES OF INCORPORATION  
OF  
SOUTHEASTERN WELLNESS INSTITUTE, INC.

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation is Southeastern Wellness Institute, Inc.

ARTICLE II

The initial principal offices of this corporation shall be 6876 Stirling Road, Davie, Florida 33024, with the privilege of having its office, or any branches, located elsewhere in the State of Florida or beyond Florida's boundaries.

The capital stock authorized, the par thereof, and the characteristics of such stock shall be as follows:

Any director, individually, or any firm of which any director may be a member, any be a party to, or may be pecuniarily or otherwise interested in any Contract or transaction of this Corporation, provided that the fact that she/he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors of this Corporation shall authorize any such contract or transaction with like force and effort.

ARTICLE X

The private property of the stockholders shall NOT be subject to payment of the corporate debtors under any circumstances. 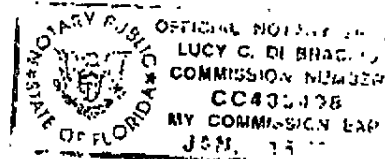
