The name of the corporation is **H & H RENTALS, INC.**

**Article II: DURATION**

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles of Incorporation.

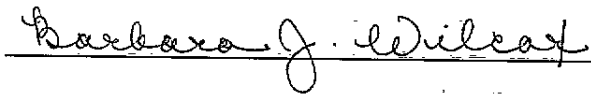
